Native Addictions Council of Manitoba's Pritchard House Rehabilitation Centre is the longest-running, Native-staffed, treatment centre in Canada.

More than 90% of the programming is based on Native Cultural Tradition, with the remainder of the program consisting of methods chosen from current addiction treatment techniques.


Pritchard House relies on a combination of Native Traditional Teachings and current addictions treatment to provide and assist people enrolled in the program.

The program meeting schedule includes, but is not limited to, the following topics:

1. Native Teachings/Therapy;
2. Pride in Native Identity;
3. Lifestyle Assessment Problem Identification;
4. Resources available, in the addictions field and in other life areas;
5. The physical, emotional and spiritual consequences of addictions in any form, on native families and cultural traditions;
6. The impact of the Residential School System on native families and cultural traditions;
7. Life-Skills;
8. Traditional Parenting;
9. Anger Management/Domestic Violence;
10. Relaxation techniques and methods of reducing overall anxiety levels;

## Referral Procedures

Intake for Pritchard House is conducted through the intake office, which is open from 8:30 am - 4:30 pm Tuesday to Thursday. A summary of these procedures are as follows:

- Contact the office and request a referral package. The package contains the following

  6. Pritchard House rules:
- All forms must be filled out and returned before admission is confirmed by intake workers.
- Admission dates vary so please contact the intake, or the front desk to learn the start dates available.
- When the referral package is returned, the intake worker will review it along with staff members of Pritchard House. After review the intake worker will then confirm with the referral agent the date of admission and, **if accepted**, will send out a letter of confirmation of acceptance.
- Clients are to be detoxed for **3 days (72 Hours) prior to treatment**. In the case of Methamphetamines, there should be 10 days of detoxification.
- Referral agents are expected to arrange transportation to and from the facility. Intake must be informed of these arrangements.
- Clients are required to provide identification when they are admitted into Pritchard House.
- Upon admission, all clients are expected to read and sign a copy of the house rules. Failure to comply with the rules will result in immediate discharge.
